**Name:** Michael Price                      **Case #**2011-008                      **Date:** December 26, 2011  
**Disposition:** Respondent violated *Ala. Code* §§ 34-36-13(a) and 34-36-6(b)(9), by performing electrical contracting without having obtained a proper license. Respondent was assessed an administrative fine of \$1,000.

**Name:** Sammy Rose                      **Case #**2011-002                      **Date:** December 5, 2011  
**Disposition:** Respondent violated *Ala. Code* § 34-36-6(b)(5), and Rule 303-X-2-.10(2)(e), by committing fraud, deceit, negligence, incompetency, or misconduct in the practice of electrical contracting. Respondent aided or abetted a person to evade the licensing provisions of *Ala. Code* § 34-36-1, et seq., a violation of *Ala. Code* § 34-36-6(b)(7) and Rule 303-X-2-.10(2)(g). Respondent knowingly combined or conspired with a person by allowing his license to be used by an unlicensed person with the intent to evade the provisions of *Ala. Code* § 34-36-1, et seq., a violation of *Ala. Code* § 34-36-6(b)(8) and Rule 303-X-2-.10(2)(h). The Board assessed an administrative fine of \$1,000 and placed Respondent on 3 years' probation.

**Name:** Larry Pollard                      **Case #**2011-002.01                      **Date:** December 5, 2011  
**Disposition:** Respondent violated *Ala. Code* §§ 34-36-13(a) and 34-36-6(b)(9), by performing electrical contracting without having obtained a proper license; and acting in the capacity of a electrical contractor under any license issued by the Board except in the name of the licensee, as set forth in the license. The Board assessed an administrative fine of \$1,500.

**Name:** Anthony B. Reid                      **Case #**2010-005                      **Date:** October 3, 2011  
**Disposition:** Respondent violated *Ala. Code* § 34-36-6(b)(5), and Rule 303-X-2-.10(2)(e), by committing fraud, deceit, negligence, incompetency, or misconduct in the practice of electrical contracting. Respondent aided or abetted a person to evade the licensing provisions of *Ala. Code* § 34-36-1, et seq., a violation of *Ala. Code* § 34-36-6(b)(7) and Rule

303-X-2-.10(2)(g). Respondent knowingly combined or conspired with a person by allowing his license to be used by an unlicensed person with the intent to evade the provisions of *Ala. Code* § 34-36-1, et seq., a violation of *Ala. Code* § 34-36-6(b)(8) and Rule 303-X-2-.10(2)(h). The Board assessed an administrative fine of \$500 and placed Respondent on 2 years' probation.
