MINUTES
Board Meeting
October 1, 2012

The Alabama Board of Electrical Contractors met on Monday, October 1, 2012, at the Board's Office located at 2777 Zelda Road, Montgomery, Alabama, in order to conduct business. Mr. Turner made a motion to approve the Journeyman Electrician applications for examination (a list available for viewing in the Board's official Book of Minutes). The motion was seconded by Mr. Cook and unanimously approved by the Board.

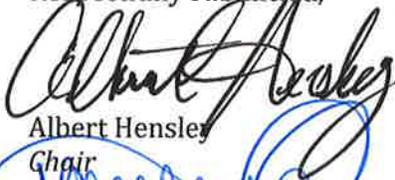
