Once the application has been approved for reciprocity/examination you will receive a notice to contact PROV. Reference, under forms section of Board's website Candidate Information Bulletin for scheduling and exam information.

#### All Forms must be original.

Complete current application <u>www.aecb.alabama.gov</u>, Work history / Affidavits. If selfemployed affidavit only is not required, sign twice under Affidavit of Application/Owner President notarized signature/s, 2x2 photograph taken in the last 6 months. Citizenship compliance with Ala. Code §34-14A-7/copy of Identification.

<u>Cashier's check or money order</u> in the amount of \$315.00 made payable to the Alabama Electrical Contractors Board. No Company or Personal Checks are accepted.

#### **Reciprocity Waiver:**

<u>An original verification letter</u> (no faxes, copies, online letters, or score sheets form testing centers) from the state licensing board verifying your license that you are in good standing, passed that State's examination receiving a grade of 70 or more. This letter must be with your application not sent separately.

#### **NASCLA Waiver:**

Score (copy accepted) report from NASCLA passing electrical contractors exam. Alabama business and Law exam giving by PROV required.
